### CORNER RECORD (PERPETUATION)

**MONUMENT: DESCRIBE NEW MONUMENT SET, OR WORK DONE TO PRESERVE EXISTING MONUMENT**

Since the corner falls in the South edge of a trail up the South Fork Walla Walla River...

A 2½" aluminum cap on 2½"x30" aluminum pipe was set with the top of the cap buried 6" below the trail level. Did not set a steel fence post on property lines since wood posts are installed at this trail crossing, attached sign 54-9 to wood post North of corner.

New bearing trees established:

A 17" ponderosa pine brs N21½° E, 59.2' scribed NE1/16S7 BT.

A 19" douglas fir brs N56½° W, 71.7' scribed NE1/16S7 BT.

New bearing trees have a brass washer stamped PLS 1106 nailed to face of blaze. Attached sign 54-3 & 54-9 to each BT and painted face of blaze & 6" red band around each BT.

Compass declination 13° East.
