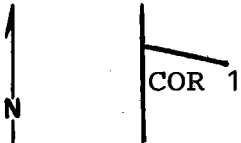

MONUMENT: DESCRIBE NEW MONUMENT SET, OR WORK DONE TO PRESERVE EXISTING MONUMENT

At position determined by survey, set a 2 1/2" by 30" aluminum pipe with 2 1/2" aluminum cap, 24" in the ground surrounded with a mound of earth and stone. Set steel fence posts North and Southeast of corner. Attached sign 54-2 to both posts and 54-4 to one post. Cap is marked as shown in diagram.
