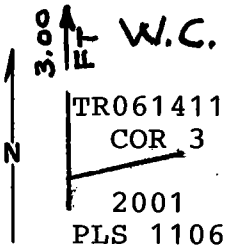

CORNER RECORD (PERPETUATION)

MONUMENT: DESCRIBE NEW MONUMENT SET, OR WORK DONE TO PRESERVE EXISTING MONUMENT

Corner falls in 30" dia. white fir (in poor condition), therefore set a witness corner S 01°00'21" W, 3.00' from corner point, a 2 1/2" x 30" aluminum pipe with a 2 1/2" aluminum cap 24" in the ground, surrounded with a mound of earth and stone. Set steel fence post South of corner and attached signs 54-2 and 54-4.

ACCESSORIES : DESCRIBE NEW BT'S WITNESS OBJECTS ETC. ESTABLISHED, OR WORK DONE TO PRESERVE EXISTING EVIDENCE

A 21" ponderosa pine bears S72 1/2°E, 40.1', scribed "X" at breast height and "BT" at base. A 6" white fir bears S13 1/2°W, 17.7', scribed "X" at breast height and "BT" at base. Bearing trees have a brass washer stamped "PLS 1106" nailed to face of blaze, painted blaze faces only, on bearing trees. Did not place signs on bearing trees.
