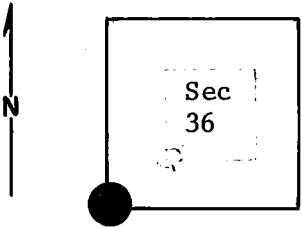

DESCRIBE BEARING TREES OR OTHER OFFICIAL ACCESSORIES FOUND

Found mound of stone in open area from which a 30" PP bears N. 79° W. approx. 226 links. Tree has B.T. poster 54-3 on it dated 1965. Tree has blaze on E. side. Blaze has been scorched by fire but scribing faintly visible. Painted red ring. 8" PP bears E. from mound of rock 52' dist. Tree has metal poster Pilot Rock Lumber Co., dated: 11/28/56

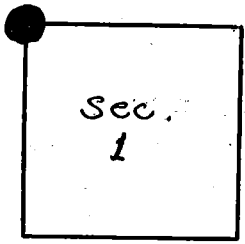
