paid them the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit:

A strip of land 60 feet wide, that is 30 feet on each side of the center line of the survey as now surveyed over and across the $S\frac{1}{2}$ of $SW\frac{1}{4}$ of Section 25, Twp 4N, Range 36 E. W. M., beginning at a point on the center line of the Weston Mountain survey known as station 184/28 which point is 525 feet north of section corner common to sections 25, 26, 35 and 36; thence along a tangent with approximate bearing of N $63^{\circ} 0' E$ for a distance of 756 feet; thence around a 3° Curve Right for a distance of 1800 feet; thence along a tangent with approximate bearing of S $62^{\circ} 59' E$ for a distance of 240.2 feet to the north and south property line of the $S\frac{1}{2}$ of $SW\frac{1}{4}$ of section 25, Twp. 4N, Range 36 E. W. M., the above point being station 212/25 on said survey, also said point being approximately 574 feet north of SE corner of $SW\frac{1}{4}$ of Section 25. The above containing 3.83 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
