All that part of the property of Eugene Eaph Tucker and Juanita Tucker, his wife, in the S<sup>2</sup> of Sec. 29, Tp. 4 N.R. 36 E.W.M., included within a strip of land sixty (60) feet wide, being 30 feet on each side of the center line of the Weston Mountain Market Road as surveyed over and across said property and as more particularly described as follows:

Beginning at a point known and designated as Sta. 46 / 84 which point is 970.0 feet West of the center of Sec. 29, Tp. 4 N.R. 36 E.W.M. thence S 56° 52' E 00 feet; thence on a 573.0 foot radius curve to the right 89.7 feet; thence S 47° 55' E. 8.8 feet; thence on a 409.3 foot radius curve to the left 228.8 feet; thence S. 79° 57' E. 10.3 feet; thence on a 286.5 foot radius curve to right 257.5 feet; thence S. 28° 27' E. 32.7 feet thence on a 238.8 foot radius curve to the left 288.0 feet; thence N. 82° 26' E. 69.8 feet; thence on a 204.6 foot radius curve to the right 315.0 feet; thence S. 9° 22' E. 7.8 feet; thence on a 204.6 foot radius curve to the left 255.8 feet; thence S 80° 59' E. 361.3 feet; thence on a 955.0 foot radius curve to the left 485.6 feet; thence N. 69° 53' E. 245.6 to a point known and designated as Station 72 / 40.9 which point is 909 feet South and 1320 feet West of the quarter corner common to Sections 28 and 29 Tp. 4 N.R. 36 E.W.M.
