Thence running in a Southwesterly direction approximately 5646 feet to Station 125 / 12 of the said survey, which Station is approximately 1210 feet West of the Section corner which is common to Sections 4-5-8 and 9 Township 3 North Range 28 East W.M., Contains 7.78 acres, more or less.
