Known as the Oregon-Washington, Milton-State Line Section Highway

Known All Men by These Presents, That H. A. Ansrach, a widower

of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Sixteen Hundred Twenty-five and no/100 Dollar paid to us, the receipt whereof is hereby acknowledged, ha granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 40 feet wide, being 20 feet on each side of the center line of said road, as surveyed over and across Fractional SE $\frac{1}{4}$ NW $\frac{1}{4}$, and Fractional SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 14, Tp. 6 N. R. 35 E. W. 1.

All that part of the property of H. A. Ansrach in the fractional Southeast quarter of the Northwest quarter, and fractional Southwest quarter of the Northeast quarter of Section 14, Tp. 6 N. Range 35 East of the W.M., included within a strip of land 40 feet wide being 20 feet on each side of the center line of the Oregon-Washington Highway as surveyed over and across said property, and more particularly described as follows:

Beginning at the intersection of the north boundary line of the H. A. Ansrach property and the center line of the Oregon-Washington Highway, Milton-State Line Section at Station 5769.6 which point is approximately 2825.0 feet West of the Northeast corner of the Fractional Southeast quarter of the Northeast quarter of Section 14, Tp. 6 N. Range 35 East of the W.M.; thence South 4° 2' East a distance of 309.6 feet, thence on a 2865.0 feet radius curve to the left a distance of 171.6 feet, thence South 7° 28' East a distance of 706.4 feet, more or less to the South boundary line of the H. A. Ansrach property, which point is approximately 1180.0 feet South and 2710.0 feet West of the Northeast corner of the fractional Southeast quarter of the Northeast quarter of Section 14, Township 6 N. Range 35 East of the W.M., said parcel of land containing 1.09 acres, more or less.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
