of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Eight Hundred Twelve and 50/100 Dollar paid to us, the receipt whereof is hereby acknowledged, ha granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 40 feet wide, being 20 feet on each side of the center line of said road, as surveyed over and across Section 14, Tp. 6 North, Range 35

East W.L.

All that part of the property owned by H.B.Zacharias in the fractional part of the NE 1/4 of the SE 1/4, and the NW 1/4 of the SE 1/4 Section, 14, Township 6 North, Range 35 East of the W.L., included in a strip of land 40 feet wide, being 20 feet on each side of the center line of the Oregon-Washington Highway, Milton-State Line Section, as surveyed over and across said property and more particularly described as follows:

Beginning at a point on the North property line of the H.B.Zacharias property at Station 14/14 of said survey, which Station is approximately 1180.0 feet South and 2710.0 feet West of the Northeast Corner of fractional SE 1/4 of the NE 1/4 of Section 14, Tp. 6 North, Range 35 East, thence South 7 deg. 28' East 371.5 feet to a point in the present County road at Station 17/65.5 of said survey, which station is approximately 1448.3 feet South and 2661.7 feet West of the Northeast corner of the Fractional SE 1/4 of the NE 1/4 of Section 14 Tp. 6 North, Range 35 East of the W.L., said parcel of land containing 0.34 acres of land, more or less.
