All that part of the property of Mary and Charles Gilbreth in the Southeast quarter of the Southwest quarter of Section Twenty-three (23) Township Six (6), North, Range Thirty-five (35), E.W.M., required for the right of Way of the Oregon-Washington Highway, as surveyed over and across said property and more particularly described as follows:

Beginning at a point in the present County Road, said point being the one-quarter section corner between Section Twenty-three and Section Twenty-six (26), Township Six (6) North, Range Thirty-five (35), E W M., and is also station 93 7/8 03 of the Oregon-Washington Highway; thence South 89° 57' West along the Southern boundary of the Mary and Charles Gilbreth property a distance of 21 feet more or less; thence North 10° 57' East a distance of 36 feet; thence on a 696.3 foot radius curve to the left a distance of 137.5 feet to a point, which is 173.9 feet North of the One-quarter Section corner between Section Twenty-three (23) and Section Twenty-six (26), Township Six (6), North, Range Thirty-five (35), E.W.M., thence South 0° 3' East a distance of 173.9 feet to the point of beginning, containing in all 0.08 acres, more or less.
