of the County of Umatilla, in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of Fifty (\$50.00) Dollar... paid them, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide, being feet on side of the center line of said road as surveyed over and across

All that part of the property of O.K. Goodman and his wife, Edna, in the Southeast quarter of the Southwest quarter of Section Twenty-six (26), Township Six (6), North Range Thirty-five (35), E.W.M., required for the right of way of the Sunnyside-Umapine Road, as surveyed over and across said property and more particularly described as follows:

Beginning at a point in the South boundary of the Sunnyside-Umapine Road, said point being 101.7 feet South 88° 30' West and 20.0 feet North 1° 05' West of the one-quarter corner between Section Twenty-six (26) and Section Thirty-five (35); thence on a 82.3 foot radius curve to the left a distance of 128.7 feet to the western boundary of the Oregon-Washington Highway; thence 81.7 feet South 1° 05' East; thence 81.7 feet South 88° 30' West to the point of beginning, containing in all 0.03 acres, more or less.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
