paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land _____ feet wide, being _____ feet on _____ side of the center line of said road, as surveyed over and across

All that part of the property of C. J. Karker and his wife, Elta, in the Northeast quarter of the Northwest quarter of Section Thirty-five (35), Township Six (6), North, Range Thirty-five (35), E.W.M., required for the right of way of the Sunnyside-Umapine Road, as surveyed over and across said property and more particularly described as follows:

Beginning at a point in the South boundary of the right of way of the Sunnyside-Umapine Road, said point being 106.4 feet South 88° 30' West and 20.0 feet South 1° 30' East of one-quarter corner between Section Twenty-six (26) and Section Thirty-five (35), thence on a 82.3 foot radius curve to the right a distance of 132.5 feet to the western boundary of the Oregon-Washington Highway; thence 86.4 feet North 0° 43' East; thence 86.4 feet South 88° 30' West to the point of beginning, containing in all 0.04 acres more or less.

Do Here and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
