paid them the receipt whereof is hereby acknowledged, granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across the South half of the North half of Section 4 Township 2 North Range 32 East W.M.

Beginning at station 1574.6 Point on curve of 5 degrees curve right whose tangent at that point bears south 15 degrees 36 minutes east, said point being approximately 4012 ft. south and 2332 ft. east of the center of section 35, Twp. 3 north, R 32 east.; thence on a 5 degree curve right 256 ft.; thence south 2 degrees, 44 minutes east 181.7 ft.; thence on a 10 degree curve left 402.8; thence south 43 degrees, 1 minute east, 103.2 ft.; thence on a 16 degree curve right, 390 ft.; to a point known and designated as station 2738.8 whose tangent at that point bears south 19 degrees 23 minutes west, said point being approximately 5253 ft. south and 2683 ft. east of the center of section 35 Twp. 3 north, R32 east W.M., Containing 1.84 acres more or less.
