---One--- Dollar paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Thirty (30) feet wide, being Thirty (30) feet on East side of the center line of said road, as surveyed over and across the North

west quarter of section 3, T. 3 N. R. 32 E. W.M. Said center line being more particularly described as follows: Beginning at a point known and designated as Station 131.769 of the said highway survey, which point is coincident with the quarter section corner common to sections 3 & 4, T. 3 N. R. 32 E. W.M., thence north 0-05' East, following the section line, 1766.7 feet to a point on the section line known as station 149.35.7 P.C. Also a strip of land Sixty feet wide, being thirty feet wide on each side of the center line of the said road, across the above described property and more particularly described as follows: Beginning at the above mentioned station 149.35.7 P.C., thence North 0-05' East 0.00 feet, thence on a 573 foot radius curve to the right, 320 feet, thence North 32-05' East, 401.1 feet, thence on a 573 foot radius curve to the left, 327.5 feet to a point known as station 159.84.3 P.T., which point is 388 feet East of the North West Corner of Section 3, Township 3 North, Range 32 East W.M.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
