All the property of C. D. Gabrielson and Minnie E. Gabrielson, his wife, in the SE 1/4 of section 29 Tp. 5, N. R. 31 E. W. 1. within a strip of land sixty feet wide, being 30 feet on each side of the center line of the Pendleton-Cold Springs Highway, as surveyed across said property, said center line survey being more particularly described as follows: Beginning at a point known and designated as station 589745.2, said point being approximately 2545 feet south and 1255 feet east of the section corner common to sections 19, 20, 29 and 30 Tp. 5 N. R. 31 E. W. 1, thence on an 8 degree curve to the left a distance of 317.3 feet, thence on a 4 degree curve to the left a distance of 202.5, thence south 68° 04' east a distance of 197.9 feet; thence on a 16 degree curve to the right a distance of 435.4 feet, thence south 1° 36' west a distance of 118.2 feet; thence on a 10 degree curve to the left a distance of 87.8 feet; thence south 7° 11' east a distance of 425.0 feet, thence on an 8 degree curve to the right a distance of 241.5 feet; thence south 12° 08' west a distance of 147.5 feet, thence on a 10 degree curve to the left a distance of 459.2 feet, thence south 33° 47' east a distance of 266.8 feet, thence on a 20 degree curve to the left a distance of 162.6 feet, thence south 66° 18' east a distance of 1427.8 feet to a point known and designated as station 634755.3, said point being approximately 190 feet south and 1495 feet west of the section corner common to sections 29, 28, 32 and 33, Tp. 5 N. R. 31 E. W. 1. said parcel of land containing 5.27 acres, more or less.
