One Dollar paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide, being feet on side of the center line of said road, as surveyed over and across

All that property of W. J. Harrah in the NW 1/4 of section 33 T 5 N R 31 E 1/4 M. within a strip of land 60 feet wide, being 30 feet on each side of the center line of the Pendleton Cold Spring Highway as surveyed and staked across said property, said center line survey being more particularly described as follows: Beginning at a point known and designated as station 646 7 95.3, said point being approximately 360 feet south an 286 feet west of the section corner common to sections 28- 29- 32 and 33, T 5 N R 31 E 1/4 M.; thence on a 1 degree curve to the right a distance of 1026.7 feet; thence south 66° 28' east a distance of 1081.1 feet; thence on a 2 degree curve to the right a distance of 352.5 feet; thence south 59° 25' east a distance of 108.0 feet; thence on an 8 degree curve to the right a distance of 256.3 feet; thence south 38° 55' east a distance of 779.9 feet to a point known and designated as station 682 7 99.2, said point being approximately 3103 feet south and 2773 feet east of the section corner common to sections 28- 29- 32 and 33, T 5 N R 31 E 1/4 M. said parcel of land containing 4.28 acres, more or less.
