paid him, the receipt whereof is hereby acknowledged, he granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide, being feet on side of the center line of said road, as surveyed over and across

All that property of J. D. Thorne in the SW 1/4 of the NE 1/4 of section 33 T 5 N R 31 E.W.L. within a strip of land 60 feet wide, being 30 feet on each side of the center line of the Pendleton-Cold Spring Highway, as surveyed and staked across said property, said center line survey being more particularly described as follows; Beginning at a point on said center line survey known and designated as station 680 + 00, said point being approximately 2581 feet east and 1873 feet south of the section corner common to sections 28-29-32 and 33, T 5 N R 31 E.W.L; thence south 38°35' east a distance of 399.2 feet; thence on an 18 degree curve to the left a distance of 310.4 feet; thence North 85°13' east a distance of 100.8 feet; thence on a 2 degree curve to the right a distance of 255.0 feet; thence south 89°41' east a distance of 215.8 feet; thence on a 6 degree curve to the right a distance of 3490 feet; thence south 69°17' east a distance of 192.6 to a point known and designated as station 696-776.1, said point being approximately 4125 feet east and 2335 feet south of the section corner common to sections 28-29-32 and 33, T 5 N R 31 E.W.L. said parcel of land containing 2.22 acres, more or less.

To Have and to Hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
