UMATILLA COUNTY }
IN THE MATTER OF OREGON ROAD,

KNOW ALL MEN BY THESE PRESENTS, That First Bank of Pilot Rock, an Oregon Corporation, in consideration of the benefits and other valuable considerations, and the sum of one Dollar Paid it, the receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed ;and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcels of land, situate in Umatilla County, in

the State of Oregon, to-wit;

Parcel No. 1.

Beginning at a point 648 feet South and 2692 feet East of the $\frac{1}{4}$ Section corner between Sections 23 and 24, T.1, S.R.31, E.W.M., Umatilla County, State of Oregon; thence N. 86° 04' East 142 feet; thence on a curve to the left 30 feet from and parallel to a 12° Curve, the central angle of which is 24° 24' 192 feet; thence North 61° 40' East 199 feet; thence South 53° 15' West 201 feet; thence South 80° 30' West 345 feet; thence North 21 feet to Place of beginning. All in Section 24, T.1 S.R.31 E.W.M., containing 0.18 acres of land more or less.

Parcel No. 2.

Beginning at a point 557 feet South 2157 feet West of the $\frac{1}{4}$ Section corner between 19 and 24, Tp.1 S.R.31 and 32 E.W.M., Umatilla County, State of Oregon; thence North 61° 40' East 618 feet; thence on a curve to the right 30 feet from and parallel to a 4° curve, the central angle of which is 9° 42' 237 feet; thence North 71° 22' East 434 feet; thence South 84° West 130 feet; thence South 73° 30' West 511 feet; thence on a curve to the left 30 feet from and parallel to a 4° curve, the central angle of which is 9° 42' 47 feet; thence South 61° 40' West 249 feet; thence South 53° 30' West 374 feet, to the place of beginning. All in Section 24, T.1 S.R.31 E.W.M., containing 1.32 acres of land more or less.

Parcel No:5

Beginning at a point 345 feet North and 1365 feet East of the Section corner common to Section 17, 18 19, and 20, T.1 S.R.32 E.W.M., Umatilla County, State of Oregon; thence North 24° 40' East 213 feet; thence on a curve to the right 30 feet from and parallel to a 14° curve, the central angle of which is 21° 30' 141 feet; thence North 46° 10' East 106 feet; thence on a curve to the right 30 feet from and parallel to a 14° curve, the central angle of which is 17° 00' 112 feet; thence North 63° 10' East 78 feet; thence North 26° 30' East 55 feet; thence North 51° 15' East 420 feet; thence North 41° 22' East 299 feet; thence North 21° 00' East 293 feet; thence North 64° East 260 feet; thence north 60° East 255 feet; thence North 38° 30' East 80 feet; thence South 64° 04' West 517 feet; thence on a curve to the left 30 feet from and parallel to a 10° curve, the central angle of which is 22° 42' 234 feet; thence South 41° 22' West 494 feet; thence on a curve to the right 30 feet from and parallel to a 10° curve the central angle of which is 21° 48' 206 feet; thence on a curve to the left 30 feet from and parallel to a 14° curve, the central angle of which is 17° 00' 144 feet; thence South 46° 10' West 108 feet; thence on a curve to the left 30 feet from and parallel to a 14° curve, the central angle of which is 21° 30' 174 feet; thence South 24° 40' West 182 feet; thence South 36° 30' East 66 feet to the place of beginning. All in Section 17, T.1 S.R.32 E.W.M., containing 2.16 acres of land more or less.
