paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Seventy (70) feet wide, being thirty-five (35) feet on each side of the center line of said road, as surveyed over and across

The Northwest Quarter of Section 21 Township 2 North Range 32 East W.M.

Beginning at a point, which point is approximately 1208 feet south and 120 feet west of the quarter section corner common to Sec. 16 and 21, T. 2 N.R. 32 EWM thence N. 11° 50' W., a distance of 0.0 feet, thence on a 2865.0 foot radius curve to the right a distance of 126.4 feet, thence N. 9° 18' W., 449.1 feet to the point of ending.

Also; All that part of the property of Constance D. Johnson, formerly Constance D. Isaacs and Nels O. Johnson her husband, in the NW 1/4 of Sec. 21, T. 2 N.R. 32 EWM included within a strip of land 60 feet wide being 30 feet on each side of the center line of the Oregon-Washington Highway, No. 8 and as more particularly described as follows;
