Beginning at a point, which point is approximately 997.5 feet south and 161 feet east of the quarter section corner common to Sec. 27 and 28, T. 2 N.R.32 EWM thence N.14° 12' E. 55 feet, thence on a 1432.5 foot radius curve to the left 469.6 feet thence N.4° 35' west 480 feet to a point on the 1/4 section line between the SW 1/4 and the NW 1/4 of Sec. 27, T. 2 N.
