The North Half of the Northeast Quarter of Section 28 Township 2 North Range 32 East W.M. Beginning at a point on the south line of the north half of the NE 1/4 of Sec. 28, T. 2 N.R. 32 E.W.M 596.3 feet west of the SE corner of the said N 1/2 of the NE 1/4 of said Sec. 28, said Township and range, thence North 40° 13' W. 697.9 feet, thence on a 2965.0 foot radius curve to the right a distance of 608.3 feet, thence N 28° 03' west 224.7 feet, thence on a 2865.0 foot radius curve to the right a distance of 127.7 feet to a point on the Section line between Sec. 21 and 28, T. 2 N.R. 32 E.W.M which Point is 1547 feet west of the section corner common to Sec. 21, 22, 27 and 28, T. 2 N.R. 32 E.W.M said parcel of land contains 2.28 acres more or less.
