paid the receipt whereof is hereby acknowledged, ha... granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet on each side of the center line of said road, as surveyed over and across the E 1/2 of Section 30, Township 4 N, Range 29

East W.M., Beginning at Sta. 821/27 of the Old Oregon Trail Highway Survey which station is approximately 1526 feet South and ___ feet ___ of the 1/4 corner which is common to Sections 19 and 30 Township 4 North, Range 29 East W.M. Thence running in a southeasterly direction approximately 3973 feet to Station 861/00 of the said survey, which Station is approximately 850 feet North and ___ feet ___ of the Sec. corner which is common to Sections 29-30-31 and 32 Township 4 N Range 29 E.W.M., containing 5.47 acres, being more particularly described as follows: Beginning at Sta. 821/27, said station being on the North and South 1/4 line through Sec. 30, T. 4 N.R. 29 E.W.M., and south 1526 feet of the 1/4 corner between Sections 19 and 30, said township and range; thence S. 49 deg. 05' E. 1805.7 feet, thence on a 4 deg. curve to the right with a delta of 13 deg. 27' 336.2 feet; thence S. 35 deg. 36' E. 1831.1 feet to a point on the section line between Sections 29 and 30, above township and range, said point being approximately 850 feet North of the corner common to Sections 29-30-31-32, T. 4 N.R. 29 E.W.M., said strip of land containing 5.47 acres, more or less.
