Beginning at a point 433.7 feet North of and 127.2 feet West of the Southwest Corner of Section 6, Township 2 North, Range 33 E.W.M.; thence North 89 degrees 19 minutes West a distance of 37.6 feet; thence North 0 degrees 28 minutes West a distance of 647.8 feet; thence South 89 degrees 19 minutes East a distance of 37.6 feet; thence South 0 degrees 28 minutes East a distance of 647.8 feet to the point of beginning.

TO HAVE AND TO HOLD the above described real property unto the said Umatilla County and to the general public for road, public thoroughfare and highway purposes forever.

Deed Noncompetent Indian Lands

THIS INDENTURE, Made and entered into this twenty-ninth day of October one thousand nine hundred and twenty-five, by and between Willie Williams of Umatilla Indian Reservation noncompetent Indian, party of the first part, and Oregon State Highway Commission of party of the second part:

WITNESSETH, That said party of the first part, for and in consideration of the sum of Ninety-two and 50/100 dollars, in hand paid, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, and convey unto said party of the second part the following-described real estate and premises situated in Umatilla County, State of Oregon, to wit:

Beginning at a point on the E. R. of W. Line of the Old Oregon Trail which point is approximately 972 feet North and 420 feet East of the center of said section 2, T. 1 N., R. 34 E., W. M., thence N. 79°17' E a distance of 300 feet thence south 10°43' east a distance of 148.8 feet, thence on a 135.8 foot radius curve to the left a distance of 57.2 feet thence S 55°8' west a distance approximately 300 feet to a point on the east R. of W. Line on the Old Oregon Trail, thence on a 435.8 foot radius curve to the right the long chord of which bears north 22°47' west a distance of 183.6 feet along said R. of W. Line, thence north 10°43' west a distance of 148.8 feet more or less to a point of beginning. Said tract containing 1.85 acres more or less.

And there is reserved from the lands hereby granted a right of way for canals and ditches constructed by authority of the United States. together with all the improvements thereon and the appurtenances thereunto belonging. And the said party of the first part, for himself and his heirs, executors, and administrators, does hereby covenant, promise, and agree to and with the said party of the second part, his heirs and assigns, that he
