TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON, FOR UMATILLA
COUNTY:--

Your petitioner, Anti Hannula, of the county of Umatilla and State of Oregon, respectfully represents and shows; that he the said Anti Hannula, has his residence upon the land described as the Southwest quarter of Section 15 in Township 4 North, of Range 31 East of the Willamette Meridian, containing 160 acres, more or less, according to the United States Government survey; all being situate and located in the County of Umatilla and State of Oregon; that he has built a house thereon, and resides thereon; that under and by virtue of the acts of Congress relating to homesteads, your petitioner filed upon said land before the Register and Receiver of the United States Land Office at La Grande, Oregon, and made Homestead Entry, No. 7850, for and on said above described land, and by virtue of said Homestead Entry, your petitioner, Anti Hannula, has made the said land his residence for more than a year last past, and still resides thereon; that the said Anti Hannula has no ~~is~~ other dwelling place or residence within said county or State; that the said residence of your petitioner is not reached by any convenient public road, now or heretofore provided for by law, nor by any road; that to reach a public road from said land, the residence of your petitioner, said Anti Hannula and the public would necessarily have to pass over the lands adjoining, which are claimed by others, to-wit: the Northeast quarter of Section 15 in Township 4 North of Range 31 East of the Willamette Meridian, claimed and supposed to be owned by Andy Larsen, and the Southeast quarter of Section 15, Township

4 North of Range 31 East of the Willamette Meridian, claimed by Harriet Hansen, and the Northwest quarter of Section 15 in Township 4 North, of Range 31 East of the Willamette Meridian, claimed and owned by Lars Hansen; all in Umatilla County, State of Oregon; that the nearest public road to the land occupied as the residence of said Anti Hannula is that which runs across the Northeast quarter and the Northwest quarter of Section 15 in Township 4 North of Range 31 East of the Willamette Meridian, north and northeast of said land on which said Anti Hannula resides; that this road is known as the "Stage Road", and ^{its nearest point} is something less than ~~one~~ ^(three quarters of) mile ~~from~~ the Northeast corner of said land of Anti Hannula; said road being more particularly shown and described on plat No. 34 of Plat Book No. 1 of the records of plats of Umatilla County, Oregon; that it is necessary that the public and the said Anti Hannula, your petitioner, shall have ingress and egress ~~to~~ to and from his said residence upon said land; *That a good road can be constructed, laid out and located from said land, the residence of said Anti Hannula, to said public county road, without doing unnecessary damage to the lands of the parties heretofore mentioned.*

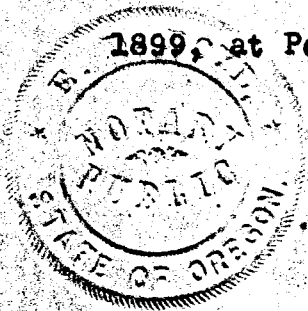
WHEREFORE, your petitioner prays your Honorable Body to cause an order to be issued in accordance with law, appointing three disinterested freeholders of said Umatilla County, Oregon, as viewers, to ~~also~~ lay out, locate and establish a public county road and highway, thirty (30) feet wide, commencing at the Northeast corner of the Southwest quarter of Section 15 in Township 4 North, of Range 31 East of the Willamette Meridian, being the residence of said Anti Hannula, and running thence ^{to be determined by said viewers} in a direction or directions, by the nearest practicable route to the said "Stage Road", at a point to be designated by the said viewers; it being the object to insure ingress to and egress from the said land of said Anti Hannula, by the public and the said Anti Hannula, from the said public "stage road" by the nearest practicable route ^{to} from the Northeast corner of said land of said Anti Hannula, and to appraise and assess the damages, if any, to the said Andy Larsen, Harriet Hansen and Lars Hansen, and to their said lands, by reason of the laying out, locating

and establishing said public road that your Honorable Body order such public road and highway to be established and maintained.

And as in duty bound, we will ever pray, &c.&c.
