DECREE OF VACATION

NOW ON THIS DAY this matter comes on to be heard for the vacation of a portion of Second Street in Terrace Park Addition to the City of Pendleton, Umatilla County, Oregon, and

It appearing to the Court that the petitioners, L. W. Owen and Lois M. Owen, husband and wife, are the owners of all of Blocks 9 and 10 in Terrace Park Addition to the City of Pendleton, Umatilla County, Oregon.

That Jens Terjeson and Isabel D. Terjeson, husband and wife, are purchasing said real property from L. W. Owen and Lois M. Owen, husband and wife, and have entered into an agreement in writing, dated the 14th. day of March, 1950, to purchase said above described real property and that the parties desire to vacate that portion of Second Street which lies between Blocks 9 and 10 in said Terrace Park Addition, a more particular description of which property to be vacated is as follows:

All that part of Second Street lying between
Blocks 9 and 10 in Terrace Park Addition to the
City of Pendleton, Umatilla County, Oregon.

That the only persons to be affected by the vacation of said street are L. W. Owen and Lois M. Owen, husband and wife, and Jens Terjeson and Isabel D. Terjeson, husband and wife, petitioners, and

It further appearing to the Court that on the 10th. day of April, 1950, this Court made and entered an order herein, requiring that notice be given of the filing of said petition, that this Court would, on Monday, the 15th. day of May, 1950, at the hour of 10 o'clock A.M. of said day, at the County Court Room in the County Court House, Pendleton, Umatilla County, Oregon, hold a hearing on said petition and consider the same and any and all objections thereto, and


It further appearing that petitioners have given such notice by posting in three public places within the vicinity of said platted

acreage and at the place of holding County Court thirty days previous to the 15th. day of May, 1950, and that due proof of the posting of said notices has been made and filed herein.


It further appearing to the Court that no opposition has been made to such petition and the Court being now fully advised, it is

ORDERED and DECREED that all that part of Second Street lying between Blocks 9 and 10 in Terrace Park Addition to the City of Pendleton, Umatilla County, Oregon, be, and the same is hereby, vacated and that all right and title thereto shall vest in the owners of Blocks 9 and 10 in Terrace Park Addition to the City of Pendleton, Umatilla County, Oregon, being the ground bordering on said street, and all right or title thereto shall vest in L. W. Owen and Lois M. Owen, husband and wife, the owners of Blocks 9 and 10 in Terrace Park Addition to the City of Pendleton, Umatilla County, Oregon, subject only to the contract of sale in favor of Jens Terjeson and Isabel D. Terjeson, husband and wife.
