NOTICE OF HEARING

WHEREAS the Umatilla County Board of Commissioners has filed it's Resolution of Intent to Vacate a portion of N. E. 45th. Street in Crispin Second Addition, to Crispin Riverside Tracts, because it deems that portion of N. E. 45th. Street in question, being a public road, has never been opened to the public and is useless to the general road system, a request has been received from adjacent property owners to Vacate said portion and the public will benefit by said Vacation in it's being returned to the tax roles, and

WHEREAS the portion of N. E. 45th. Street in Crispin Second Addition to Crispin Riverside Tracts requested to be Vacated lies entirely south of Queen Avenue, and

WHEREAS the Umatilla County Board of Commissioners has directed the Umatilla County Roadmaster for a report giving his opinion on the necessity for such VACATION and whether the section in question is in fact useless to the general road system of the county, now therefore

BE IT RESOLVED that the true copies of the Notice of Hearing, properly certified to be such by the Umatilla County Clerk, shall be posted by the Roadmaster or his assistants in three (3) places in the vicinity of the said portion of road to be VACATED; that one (1) copy be posted upon the bulletin board in the west corridor of the Umatilla County Courthouse in Pendleton, Oregon, said Umatilla County Courthouse being the place where the Umatilla County Board of Commissioners' meetings are held; that copies shall be mailed to the record owners of the land on which the county road is to be VACATED; and that this Notice of Hearing be duly entered in the Commissioner's Journal, now therefore

THE Umatilla County Board of Commissioners ORDERS a hearing on the Roadmaster's Report to be held in Room 114 of the Umatilla County Courthouse in Pendleton, Oregon, on the 11 day of December, 1974, at 10:00 a.m. o'clock, at which time the Umatilla County Board of Commissioners will consider the Roadmaster's Report and any objections thereto and unless good cause

is shown why the same should not be done, shall thereafter ORDER the portion of N. E. 45th Street in the Crispin Second Addition to Crispin Riverside Tracts as described above to be vacated.
