NOTICE OF HEARING

WHEREAS a Petition and Consent to Vacation has been presented to the Umatilla County Board of Commissioners, and

WHEREAS the petition is a request to Vacate Morrow Street, Kik City Addition, County of Umatilla, State of Oregon, as described below:

A strip of land 60 feet wide and 278.07 feet long lying between Block E Kik City Addition on the North and Block F on the South, Section 22, Township 5 North, Range 28 East, W.M.

WHEREAS the portion of Morrow Street to be Vacated has been requested by all adjoining landowners, and

WHEREAS the Vacation as requested will not inconvenience the motoring public, and

WHEREAS the Taxpayers of Umatilla County will be benefited by returning said right-of-way to the tax roles, and

WHEREAS the Umatilla County Board of Commissioners has directed the Umatilla County Roadmaster for a report asking his opinion on the necessity for such Vacation and whether it is in fact in the best interest of the general road system of the County, therefore


BE IT RESOLVED that true copies of the Notice of Hearing, properly certified to be such by the Umatilla County Clerk, shall be posted by the Umatilla County Roadmaster or his assistants in three (3) places in the vicinity of the said portion of road to be Vacated; that one (1) copy be posted upon the bulletin board in the West corridor of the

Umatilla County Courthouse in Pendleton, Oregon, said Umatilla County Courthouse being the place where the Umatilla County Board of Commissioner's meeting are held; that copies shall be mailed to the record owners of the land on which the county road is to be Vacated; and that the Notice of Hearing be duly entered in the Commissioners' Journal, therefore the Umatilla County Board of Commissioners

ORDERS a Hearing on the Roadmaster's Report to be held in Room 114 of the Umatilla County Courthouse in Pendleton, Oregon, on the 6 day of May, 1981, at 10:30 AM o'clock, at which time the Umatilla County Board of Commissioners will consider the Roadmaster's Report and any objections thereto and, unless good cause is shown why the same should not be done, shall thereafter Order that portion of Morrow Street described above be Vacated.
