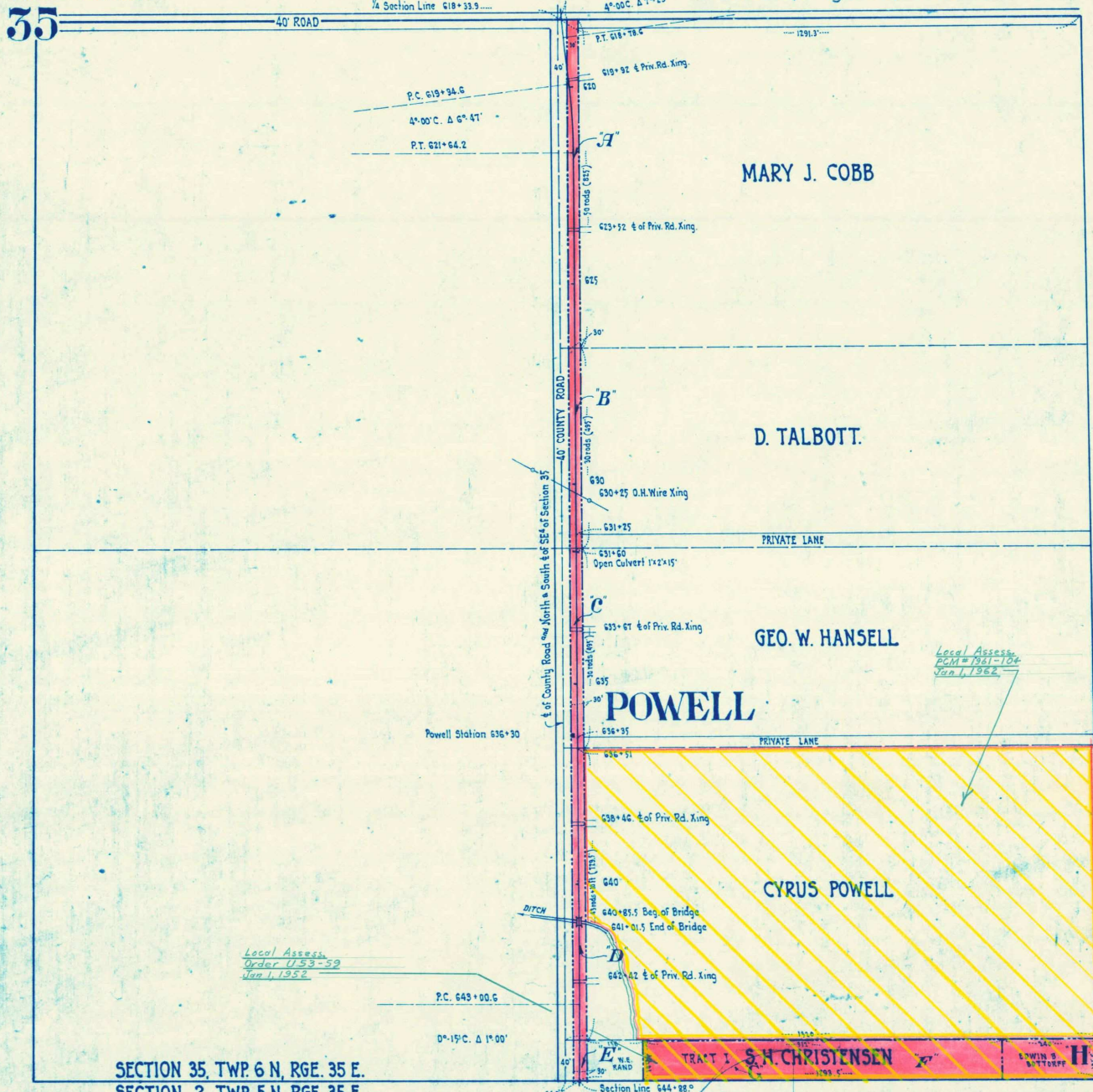
Main Line, Walla Walla to Milton Right of Way Plat
